REGISTRATION AND PAYMENT

After the signature of the participation contract, an invoice will be sent to exhibiting company.

Payment Terms and method:

- 50% upon booth reservation and 50% two months prior to exhibition opening date.
- Payment is done through money transfer.

SPACE ONLY STAND SPECIFICATIONS

All Exhibitors will be responsible for designing and constructing their own stands, including flooring, walls... Etc. through their own agent or contractor.

This does not include any stand fittings or flooring. It only provides electrical supply and enables the exhibitors to create their own individual stand build.

Exhibitors are reminded that, where their stand joins another Exhibitor's area, the back of any dividing walls, panels or exhibits must be masked properly in a presentable way to present a neat appearance. Also, it is the responsibility of Exhibitors not taking shell stands to make their own arrangements for the provision of suitable floor covering for their area.

Kindly please note that:

- Octanorm stand shells are not accepted.
- Stand height or back wall should not be more than 4 meters length.

CUSTOMS REGULATIONS JEWELLERY AND WATCHES

1- Jewellery

All gold jewellery shipped to Saudi Arabia for exhibition purposes must be manufactured with a fineness of 18 carats or higher which must be confirmed on the documents.

Each jewellery item must bear a tag marked with the respective reference number of the invoice and the fineness (if the latter is not engraved on the jewellery itself).

2- Watches

CITIES-Certificate (Convention on International Trade in Endangered Species of Wild Fauna and Flora) will be needed for temporary import into Saudi Arabia which is a member country of CITES.

The Original Certificate needs to be stamped by the customs authorities of the country of origin and accompany the shipment.

We strongly recommend not to take CITES-watchstraps into Saudi Arabia since there is no procedure to issue a return-CITES which will result in destroying the respective CITES-watchstraps before repatriating to the country of origin.

3- Empty jewellery cases

Saudi Arabia does not allow the import of spare empty jewellery cases. Exhibitors are allowed to take one empty case per one item of jewellery into the country.

DUTY ON JEWELLERY, DIAMONDS, STONES & WATCHES

According to the GCC Gold and Diamond agreement (Gold Jewellery), the customs duties are a refundable 5% in addition to a refundable 5 % (VAT), a total of 10% of the value of the exhibited items (CIF basis).

1. In case of cash payment, the amount has to be transferred to Sunaidi Expo 3 weeks prior to the starting date of the exhibition.
2. In case of bank guarantee, the exhibitor has to issue a bank guarantee by a local bank in his/her home country after such, a bank has to then finalize the applicable procedures with a Saudi local bank (The National Commercial Bank - NCB) which issues the guarantee in Arabic language and in Saudi riyals which is necessary for the completion of the Saudi custom procedures.

Upon the end of the fair period, the Saudi customs shall release the deposit within 15 - 20 working days from completion date of the customs procedures.

In case of the bank guarantee, the NCB (National Commercial Bank) shall release the guarantee within 15 - 20 working days from completion date of the customs procedures.

ARRIVALS, DEPARTURES OF EXHIBITORS, CUSTOMS CLEARANCE AND SHIPPING

1- HANDCARRY Shipments:

All handcarry-shipments must arrive/depart at airport of Jeddah only

Documents required:

a. Commercial Invoice:

- Minimum 2 sets of detailed invoices with official market values indicating the no. on the tag no., price per item, detailed descriptions of goods, carats, gross and net weights in grams. CIF value and the manufacturer's name, the total weight in grams of items and total price in U.S. Dollars must be clearly stated on the invoice.

The invoice must be issued in USD (United States Dollars) only and in English or Arab language and has to be stamped and signed.

- Colored picture of each individual Jewellery piece **(within invoice or separate attachment)** mentioning its number (as per the invoice), price in (\$USD) and its weight in grams.

d. Arrival date of Exhibitors:

e. Travel Arrangements

Please note that exhibitors are kindly requested to make your own booking and ticketing from their country to Saudi Arabia and back and also between Jeddah and Riyadh, forth and back.

Please inform us about the flights dates and numbers so we can arrange the transportation.

f. Arrival/customs procedures

All exhibitors arriving with valuables will be met upon landing at the airport -Jeddah (VIP-terminal). A car-service from the aircraft to the VIP-terminal will be arranged by the organizer.

Customs inbound procedures (incl. physical check of merchandise) will be effected upon arrival at the VIP terminal.

After passing the inbound customs clearance, the goods will be available for pick-up by the exhibitor at the strong-room at the Hilton-Jeddah.

For exhibitors' hand carrying their jewellery to Riyadh, they should inform us earlier so we can prepare the authorization papers.

2- AIRFREIGHT Shipments:

All AIRCARGO-shipments must arrive/depart at airport of Jeddah only

Due to local regulations, airfreight shipments must be packed in Solid sealed boxes.

Documents required:

a. Commercial Invoice:

- Minimum 2 sets of detailed invoices with official market values indicating the no. on the tag no., price per item, detailed descriptions of goods, carats, gross and net weights in grams. CIF value and the manufacturer's name, the total weight in grams of items and total price in U.S. Dollars must be clearly stated on the invoice.

The invoice must be issued in USD (United States Dollars) only and in English or Arab language and has to be stamped and signed.

- Colored picture of each individual Jewellery piece (within invoice or separate attachment) mentioning its number (as per the invoice), price in (\$USD) and its weight in grams.

d. Deadline for documents

Copies of all certified documents must be sent latest by **Sunday March 31st, 2019**

e. Consolidated shipments:

Exhibitor has to instruct its air cargo agent at origin to dispatch the shipment under single AWB (Airway Bill) only. Consolidated cargo under HAWB (House-Airway Bill) is not permitted in or out of the Kingdom of Saudi Arabia.

f. Arrival dates of shipments:

Between **Sunday March 31st, 2019** and **Tuesday April 2nd, 2019, 6:00 pm** at the LATEST!

g. Travel Arrangements

Please note that exhibitors are kindly requested to make your own booking and ticketing from their country to Saudi Arabia and back and also between Jeddah and Riyadh, forth and back.

Please inform us about the flights dates and numbers so we can arrange the transportation.

h. Arrival/customs procedures

Airfreight shipments must be clearly marked, properly packed and sealed in solid suitable boxes. Shipments declared as “valuable Cargo” will be stored in the customs-controlled vault within the cargo section of Jeddah-Airport until customs clearance.

The exhibitor has to be present during the customs inbound procedures.

Customs inbound procedures will (incl. physical check of merchandise) will be effected within the customs office at the Cargo Building of Jeddah-airport on **Sunday April 7th, 2019**

Or in the morning of Monday April 8th, 2019.

After passing the inbound customs clearance, the goods will be available for pick-up by the exhibitor at the strong-room at the Hilton-Jeddah.

For exhibitors' hand carrying their jewellery to Riyadh, they should inform us earlier so we can prepare the authorization papers for transportation.

3- Departures after end of exhibitions

All shipments (Handcarry/aircargo) must depart from **Airport of Jeddah only.**

Outbound procedures/customs inspections will take place at the VIP terminal of Jeddah airport starting from **Sunday April 21st, 2019** before the departure of the exhibitor.

The exhibitor should be present 3 hours before the flight at the VIP terminal for customs inspection.

For exhibitors leaving by handcarry, **outbound flights from Jeddah should not depart any earlier than 10:00 am on Sunday April 21nd, 2019.**

Upon Customs inspections, all goods will be sealed in bags with customs seals. Customs Authorities will individually hand-over the sealed bags to exhibitors at the plane.

For Exhibitors leaving by handcarry, they should provide a copy of their passport and ticket to the organizers or the Customs during the outbound inspection.

For Exhibitors leaving by Airfreight, the airline will receive the shipment at the Customs vault.

Ground Transports in Saudi Arabia/ Security / Insurance Coverage

Transport by armoured vehicles will be fully organized by SunaidiExpo on following routes:

- Jeddah-airport to the fair ground Hilton Hotel Jeddah
- Jeddah Hilton Hotel to the fair ground Al-Faisaliah Hotel Riyadh
- Al-Faisaliah Hotel Riyadh to Jeddah-airport

At both the fair locations all shipments will be kept in a secured area (strong room) handled by the security company and can be picked up by authorised persons (exhibitors).

Both strong rooms are guarded 24 hours by armed guards and are CCTV-equipped.

There is **no standard insurance coverage** for the exhibits neither by SunaidiExpo nor their subcontractor partner (AMNCO Saudi Arabia).

PASSPORTS AND VISAS

Passport and Visa Information:

- All Saudi Arabia visitors must be in possession of a passport valid at least six months beyond the estimated stay.
- Visas are not required by GCC nationals. All other nationalities require a Single Entry Visa to enter Saudi Arabia.
- Women under 30 years are unlikely to get visas to enter Saudi Arabia, though this depends on the necessity.
-

It must be noted that any person holding a passport with any indication of travel to Israel will result in refusal of entry to Saudi Arabia.

OBTAINING A COMMERCIAL VISA TO PARTICIPATE IN AN EXHIBITION IN SAUDI ARABIA INVOLVES RECEIVING A MOFA APPROVAL LETTER (AN APPROVAL FROM THE SAUDI MINISTRY OF FOREIGN AFFAIRS (MOFA)).

• **Requirements for the MOFA Approval letter:**

1. A clear scanned copy of the applicant passport.
2. For the applicants living in the GCC countries, a clear scanned copy of the GCC residency.
3. Complete the enclosed Visa Application Forms 1 & 2
 - Visa Form 1 should be completed only once for the exhibiting company.
 - Visa Form 2 should be completed individually for each applicant.

Please make sure to clearly indicate the city where the Saudi Embassy or Consulate is located and in which you will have your visa endorsed (stamped).

• **Procedure**

- The Organizer will apply for the applicant at the Ministry of Foreign Affairs (MOFA) website.
- If the applicant is approved, the organizer will receive a letter of invitation (MOFA approval letter) that will be sent to the exhibitor.
- The Exhibitor will then do the necessary visa formalities at the Saudi Embassy or Consulate in the city designated in the application to stamp the Visa on the passport prior to travelling.

IMPORTANT: No visa application can be accepted later than 1 month prior to opening of Exhibitions.

SAFETY AND SECURITY

1. The Organizers provide a security company with a 24 hour security and will supply at the exhibitor's expense and upon his request guards outside of the exhibitor stand.
2. The organizers will provide exhibitors' badges for security reasons to every member of the team working in the booth. The badges must be worn in order to allow the exhibitor access into the hall. All exhibitors are obliged to wear their badges throughout the exhibition period.
3. After customs clearance an armored vehicle with armed guards provided by Sunaidi Expo will be waiting to transfer the valuable goods to the Venue for securing in the rented safe on the exhibitor's stand.
4. On leaving Jeddah the same armored transport and customs arrangements will apply.

HOTELS AND RESERVATIONS

Hilton Jeddah Hotel is recommended by Sunaidi Expo .The strikingly modern Jeddah Hilton hotel, Saudi Arabia's largest overlooks the Red Sea and is just 15 minutes from the airport and where the Jewellery Salon exhibition is held.

GENERAL INFORMATION

Health Requirements

It should be noted that although current health regulations do not require passengers to be vaccinated against Smallpox and Cholera, these regulations are prone to fairly frequent change. It is therefore recommended that all persons visiting Saudi Arabia are in possession of documents certifying vaccination.

Yellow Fever vaccination is only required if arriving within 6 days after leaving or transiting countries, any parts of which are infected areas. It is advisable to take the appropriate precautions and specialist recommendations.

Personal Customs Facilities

Visitor's personal effects are not subject to duty. Free import of the following is permitted: 400 Cigarettes or 100 Cigars or 500 grams of tobacco, a reasonable quantity of perfumes. Customs charges are levied on non-personal photographic cameras, typewriters etc. If these articles are re-exported within 90 days, customs charges may be refunded. It is advisable not to enter the country with film in your camera. Video Tapes are confiscated on entry to Saudi Arabia and a receipt is issued. When satisfied as to be the content of the tape, the authority will order a release and it can be reclaimed.

Currency Regulations

The amount of currency that may be taken into or out of the Country couldn't exceed 60000 SAR.

Photography

Organizer's official photographer will be available for all photographic requirements. Exhibitors should indicate whether they require this service to the Organizer.

Climate

Jeddah is warm and humid for most of the year. Temperatures seldom rise above 38 degree centigrade but humidity can exceed 90%. During the winter season (mid-November to mid- April) it is usually acceptable by European standards and the prevailing north-west wind does not help to relieve the heat.

Clothing

Light weight suits are adequate for most of the year. The Organizer suggests exhibitors to carry sufficient light clothing including cotton shirts.

Languages

Arabic is the official language although English is widely spoken business circles.

Currency

The Saudi Arabian Monetary unit is the Riyal which is divided into 100 Halalahs. The notes are issued in 1, 5, 10, 20, 50, 100, 200, and 500 Riyal denominations. Coins are issued in 5, 10, 25, 50, and 100 Halalahs.

Banks

Most of the major international banks are represented in the Kingdom.

Business hours are 09:30 – 16:30 Hrs. Sunday to Thursday. Friday and Saturday are the weekly holidays.

Credit Cards

All major credit cards are widely used in Saudi Arabia in almost all hotels and retail outlets.

Television

In addition to Arabic broadcasting, Saudi Arabian Television's channel 2 broadcasts in English and features a variety of mainly American films and serials. Daily news programs are broadcast in both French and English.

Also Satellite/Cable television is available in all the major hotels.

Hours of Business

The Kingdom of Saudi Arabia is 3 hours ahead of Greenwich Mean Time.

Embassies (generally)

08:00-14:00 Hours Sunday to Thursday.

Government Departments

07:30 – 14:30 Hours Sunday to Thursday.
(Friday and Saturday are weekly holidays)

Shopping

(No Standard Hours) Approximately 09:00 – 13:00 and 16:30 – 21:00 Hours daily.
